LOCATION:

Prantik Housing Project is about 15 minutes drive from Tollygunge Metro Station on Mahatma Gandhi Road and within close proximity of the hubbub of city life and the locality of Haridevpur. It is under P.S. Thakurpukur. The Board is developing Housing Complexes for about 5000 families on a vast area of about 55 acres of land. This housing complex will also accommodate a super market, telephone exchange and other modern facilities. The project is profusely dotted with water bodies and organized greens and playgrounds to generate a healthy and pleasant living condition. Mahatma Gandhi Road passes abutting this Housing Complex. GENERAL FACILITIES
