

#### LOCATION

The project site is located near 1.5 km away from Serampore Railway station on the G T Road. Delhi Road is further 1 km away. The project is also closed to other facilities. The site is under the jurisdiction of Serampore Police Station, about 2 km away. Local market, ESI hospital, petrol pumps and educational institutions are located at a distance of 0.25 to 1 km. Cinemahall, shopping complex, local court are within a radius of 2 km. the well known Walls Hospital, local college and ferry ghat are all within a distance of 2.5 kms.




#### **THE SCHEME**

Structure : Brick Built.

- Flooring : Silver Grey mosaic flooring in Bed Rooms, Living Rooms & Toilet. Grey Artificial stone flooring in Kitchen & Stair.
- Wall finish : Exterior Cement based paint on plastered surface. Interior : White wash on plastered surface.
- Staircase : APS flooring.
- Doors : Factory made paneled timber door.
- Windows : Fully glazed steel window with integrated grill.
- Water Supply : Water is available in the campus.

Internal Electrification : Wiring, fitting/ fixtures etc. done as per guided schedule.


